

## Regulations

These regulations set the rules for the participation in the Rights Centre Project ("Project"), within the organization of the 36<sup>th</sup> Salone Internazionale del Libro di Torino ("Salone").

### Art. 1. Definitions

"Project" means the initiative Rights Centre organised by Salone del Libro on the 8-9-10 May 2024 at Centro Congressi Lingotto.

"Regulations" means these general conditions

"Organisation" means the owner of the Organisation of the Fair

"Participants" means those who participate in the Project

### Art. 2 Participation Rules

The project is dedicated to Italian and foreign publishing houses, scouting and literary agencies and production companies interested in buying and selling publishing and translation rights and audio-visual rights for the adaptation of editorial and literary content for film, television and theatre.

## 2.1 Literary agents, scouts, foreign rights managers, producers

All literary agents, scouts, foreign rights managers, producers are requested to purchase a table at the following conditions:

#### 2.2 Editors and publishers

Editors and publishers can participate by purchasing one of the following tickets\*:

- Rights Centre Exhibitor Espositore € 85 (VAT included) valid for 6 days (from 8th until 13th May), granting 4 daily accesses to Rights Centre (Centro Congressi Lingotto) and Salone del Libro exhibition area.
- Abbonamento Rights Centre € 48 (VAT included) valid for 3 days (from 8th until 10th May), granting 4 daily accesses to Rights Centre (Centro Congressi Lingotto) and Salone del Libro exhibition area.
- Intero Rights Centre € 25 (VAT included) valid for 1 day (8th, 9th or 10th May), granting 4 accesses to Rights Centre (Centro Congressi Lingotto) and Salone del Libro exhibition area.

\* Tickets holders must pass through the gates reserved for them, both on entry and exit. During the same day, after the first access, people will be allowed to enter only if the ticket has been previously checked at the exit by the personnel in charge.

#### Art. 3 Access to participants

Rights Centre at Centro Congressi will be open from Wednesday 8th until Friday 10th May 2024 in the following hours:

- Wednesday, from 10.30 a.m. to 6.00 p.m.
- Thursday and Friday from 10.00 a.m. to 6.00 p.m.

Salone will be open from Thursday 9<sup>th</sup> until Monday 13<sup>th</sup> May 2024 in the following hours:

- Thursday, Sunday and Monday from 10.00 a.m. to 8.00 p.m.

- Friday and Saturday from 10.00 a.m. to 9.00 p.m.

## Art. 4 Cancellation

Should the Project be cancelled for any reason, the Participant will be promptly notified and refunded of the amount paid. Any damage or indemnity is expressly excluded. The Participant hereby waives any right to claim any damages or indemnities.

## Art. 5 Right of Withdrawal

Withdrawal from the Project, for any reason, must be communicated by certified email addressed to the Organisation at least 30 days before the beginning of the Project. In this case the Organisation will issue a voucher, equal to the amount paid for the purchase of the table, valid for the next edition of the project. In the event that the withdrawal is received after the 30<sup>th</sup> day prior to the beginning of the Project, the Organisation will keep the amount paid by the Participant and will be entitled to collect any sums still due from the Participant.

#### Art. 6 Damages

The Participant shall be liable for all damage caused directly or indirectly to the Organisation, the Participants and any other third party by him, his employees, auxiliaries and/or collaborators within the project.

#### Art. 7 Further provisions

The Participant undertakes to comply with the regulations in force, including those aimed at preventing the spread of covid-19 and the rules contained in the protocols that the Organisation will adopt for the event.

## Art. 8 Surveillance

The Participant is responsible for the custody and surveillance of the space purchased for the duration of the Project (both when open to the public and when closed).

The Organisation will not therefore be responsible for objects or goods left unattended.

Salone Libro Srl in compliance with the principles of lawfulness, the purpose limitation and the data minimisation, pursuant to art. 5 of the GDPR will retain

personal data for the period necessary to achieve the purposes for which they are collected and processed. In any case, the need to keep the data will be checked every six months.
